He believes that CNAC at that time has facilitated the flow of ideas and people between America and China, spurred innovation, and contributed to a 'free world' and strengthen international rule of law. Responsible leadership and operational excellence were CNAC hallmarks at that time, and its corporate citizenship framework – make money, make it ethically and make a difference – enabled CNAC to contribute to society and create value in ways that were true to CNAC strategy and culture at that time.
